CIRCULAR # 28 OF 2012

Filing of Semi Annual Returns by Modarabas Regarding Information on Related Party Exposure

Please find enclosed herewith the formats for standardized periodic reporting of information by the Modarabas pertaining to their exposure in related party. The term related party would carry the same meaning as defined in International Accounting Standard – 24, adopted in Pakistan.

2. All the Modarabas are required to submit the information as per the attached formats on six monthly basis. The information shall be submitted in a manner that for the period ended on 30th day of June every year, the information should be submitted by the following 30th day of September while for the period ended on 31st day December every year the information should be submitted to SECP by the following 31st day of March. However, the first reporting of information by the Modarabas shall be made by 31st day of October 2012 for the period ended on 30th day of June 2012.

3. The information is required to be submitted in soft form (in MS Excel) through email to <u>ahmer.fareedi@secp.gov.pk</u> and <u>aqureshi@secp.gov.pk</u>. Soft copy of the referred formats will be sent to all the entities through email for their ease.

4. All Modarabas are required to ensure meticulous compliance with this circular in letter and spirit, failing which action will be taken in terms of applicable provisions of the law.
