No. (I)/2013.- The following draft of amendment in the Companies (Registration Offices) Regulations, 2003, which is proposed to be made by the Securities and Exchange Commission of Pakistan, in exercise of powers conferred by section 506A of the Companies Ordinance, 1984 (XLVII of 1984) read with sub-section (2) of section 466 thereof and clause (c) of section 43 of the Securities and Exchange Commission of Pakistan Act, 1997 (XLII of 1997), is hereby published, as required by proviso to sub-section (1) of section 506A of the said Ordinance, for the information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration after fourteen days of its notification in the Official Gazette.
