**Collection of Duties & Taxes on 31<sup>st</sup> December, 2018 by Authorized Branches SBP, NBP and National Institute of Facilitation Technologies (NIFT)**

This is with reference to the FBR letter D.O.No.1(137)STM/2017 dated 21<sup>st</sup> December,2018 (copy enclosed) regarding collection of duties and taxes for extended hours and timely reporting and deposit of Government receipts / payments by NBP and SBP-BSC Offices **on 31<sup>st</sup> December, 2018 (Monday)**.

In this regard, it is advised to ensure compliance of the following operational instructions for 31<sup>st</sup> December, 2018 with regard to collection and settlement/clearing of federal and provincial government transactions on month end:

- The NBP branches (A, B & C), as well as field offices of the SBP Banking Services Corporation (BSC), shall observe extended banking hours up to **08:00 PM on 31<sup>st</sup> December, 2018**.
- The NBP branches (A, B & C) will settle their transactions on same day i.e. **31<sup>st</sup> December, 2018** with respective SBP-BSC Offices for which purpose a special clearing will be arranged at **5:30 PM by the NIFT on 31<sup>st</sup> December, 2018**
- The NBP shall settle their cash transactions with SBP-BSC field offices / head office latest by 10:00 PM on 31<sup>st</sup> December, 2018.

Please ensure meticulous compliance of the above.
