

COLLECTION OF DUTIES & TAXES BY NBP ON 30th March, 2019 (Saturday)

In pursuance of the request of Federal Board of Revenue (FBR), following instructions regarding Government banking business on March 30, 2019 may please be complied with:

- i. The NBP branches (A, B & C), as well as field offices of the SBP Banking Services Corporation (BSC), shall observe extended banking hours up to 10:00 PM on 30th March, 2019.
- ii. The NBP branches (A, B & C) will settle their transactions on same day i.e. 30th March, 2019 with respective SBP-BSC Offices for which purpose a special clearing will be arranged at 8:00 PM by the NIFT on 30th March, 2019
- iii. The NBP shall settle their cash transactions with SBP-BSC field offices / head office latest by 12:00 midnight on 30th March, 2019.

It is clarified, that on the above day, NBP / BSC field offices shall NOT execute any payment out of Government accounts except such payments as they relate to payment of FBR taxes and duties out of one Government account to another Government account.

Please ensure the meticulous compliance of the above.
